



#### Patient Navigation Sustainability Assessment Tool (PNSAT) Report

#### Patient Navigation for Preventive Cancer Screening Sustainability

Many factors can affect sustainability, such as funding, organizational characteristics, availability of engaged champions and elements of evaluation and communication. The Patient Navigation Sustainability Assessment Tool (PNSAT) allows clinical settings to rate their patient navigation practice on the extent to which they have processes and structures in place that will increase the likelihood of sustainability. Assessment results can then be used to identify next steps in building practice capacity for sustainability in order to position efforts for long term success.

#### Interpreting the Results

The table to the right presents your overall sustainability score and the average rating for each sustainability domain based on the responses you provided. The remainder of the document presents the ratings for indicators within each domain. There is no minimum rating that guarantees the sustainability of a patient navigation practice. However, lower ratings do indicate opportunities for

- Identify 1-2 priority domains for change
- Describe:
  - Sustainability goal and question
  - Partners
  - Resources needed
  - Actionable steps and timeline
- Focus is on engaging in the iterative process

# Statewide Integration of Sustainability Implementation-Colorado

#### Axis Health-Durango, Cortez, Pagosa Springs

Goal: Axis Health System will implement updated workflows for CRC screening and other preventive screenings/chronic conditions utilizing health navigation/community health workers, as well as an updated EHR, in order to: standardize processes across clinic sites that lead to short-term improvements in clinical team efficiency and long-term improvements in health outcomes and decreased costs

Goal: By June 2021, Melissa Memorial will have increased their overall CRC screening colonoscopy rates to an average of 150 patients screened per year, with a focus on reducing refusal rates among patients that are contacted about screening through in-reach strategies and improving in-reach/outreach strategies to expand awareness and referrals among the northeastern Colorado Hispanic patient population

#### Salud Family Health, Longmont and several Northern CO locations

Goal: By June 2021, Salud will make the business case for direct services reimbursement for navigation in collaboration with CCSP by demonstrating the value and effectiveness of patient navigation for potentially preventive cancer screening, cardiovascular disease, and diabetes management using case studies and patient outcomes data

#### **Uncompahgre Clinic – Norwood**

Goal: Uncompany clinic will strengthen workflow integration and funding stability to maintain Tier 1 Status based on HRSA recommendations



### **Engaging Clinic By:**

- Reviewing the online assessment and pulling questions to ask clinics
- Holding guided conversations
  - In-person with clinics to assess current status and planning future TA needs



# **Examples of Questions Asked**

#### **Review Evidence-Based Interventions Center Focused On:**

- What colorectal cancer screening (CRCS) interventions were funded & implemented?
- What occurred in your center to implement these interventions?
- What policies have been created or improved?
- Does your center have a CRCS champion? If not, why?

#### **Sustainability Planning**

- Does your center have a written sustainability plan?
  - If yes, please describe. Anything specific to patient navigations?
- Describe the current funding situation (other than this grant) supporting CRCS interventions & staff.
- How do you see your center contributing to the sustainability of your efforts to provide cancer screening and prevention patient navigation?

   QI Directors and Patient Navigators
   Include clinic leadership, MAs, IT, fiscal, front desk staff
