Risk Assessment and Screening To Detect Familial, Hereditary And Early Onset Colorectal Cancer: Putting Knowledge Into Action

Given the growing concern of the NCCRT about poor screening for those with a family history of CRC and the growing problem of early onset CRC, the NCCRT has commissioned a new primary care clinician's toolkit that aims to improve the ability of primary care clinicians to systematically collect, document, and act on a family history of CRC and adenomas polyps, while also educating clinicians on the need for more timely diagnostic testing for young adults who present with alarm signs or symptoms of CRC and ensuring that those patients receive a proper diagnostic work up. Come get an in depth look at the toolkit and participate in exercises that will help you think through how to apply it in practice.
